Mayor Howard reported the statewide tornado drill will be held on March 23rd at 9:50 a.m. and Enon sirens will also be tested. The interest rates for the water EPA loans have dropped from 3.26% to 3%, a savings of \$4,500 to the village.

Administrator Ross gave updates for the departments:

The building plans for the new Speedway have been submitted to the County and should be approved this week; June 6th is the start date for Speedway. Jonathan Wocher addressed council regarding the main intersections of Main Street and Xenia Avenue and requested approval to allow a right turn lane using a yield sign during the rebuilding of Speedway. Administrator Ross, Chief Wilcox and council are not in agreement of a yield sign; the light at the intersection will remain. Councilman Hanna and Whitacre suggested that a right turn on red be reviewed at a later date for traffic flow.

Chief Wilcox reports:

Chief Wilcox reported the Farmer's Market will resume on May 10 this year at Settler's Park. The Active Shooter class had 32 individuals sign up for the class. Driving under suspension tickets have increased within the village; the training session held on this topic help attributed to the increase in tickets. THE Enon Police Department has a reputation of well trained employees and this is one reason for the turnover within the Police Department. Circus tickets will be going on sale soon at the Government Center, Rite Aid and Wesbanco for the May 5th performance at Indian Valley School.
