Mrs. Thome reported a public notice form Clark County Solid Waste Management District for a public comment period and public hearing for draft Clark County solid waste management plan update. Any resident interested in dates and times please see Kristy for a copy of the public

notice. Thome reported the price of road salt has increased with purchasing in conjunction with ODOT; the salt will cost \$75.93 per ton. All orders must be made by the end of March 2019. Currently the salt bin is full. The radio read meters still has a few issues but on a good note Badger Meter is of great assistance with the new technology the village has put in place. The meters are a great data resource to the village and resident if a water leak occurs. Councilman Whitacre suggested a notice be placed on the water bill as to call the village first if a resident suspects a water leak is occurring; by doing so a water usage detail sheet can be generated for assistance of the water leak time frame. The BZA approved a conditional use of a garage at 425 East Main Street as a larger new garage was constructed.

Chief Wilcox Reports:

Chief reported National Night Out was a great time with approximately 700 people in attendance. A big thanks to all businesses who donated to National Night Out and much appreciation to all who attended the event. The car show will be held on August 26th from 4-8 p.m. The department is planning another shredding event on either September 20 or 27. Residents can bring their papers to be shredded at no cost.
